Healthy Learning Environment

Dear Families and Students,

I wanted to take a moment to update you on the progress that has been made over this past week with our new Vape sensors. Since last Tuesday, the number of alerts have declined by Over 50%. We have also observed an increase in students reporting concerns for their friends health and wellness, which is providing us with the information that is needed to work towards implementing supports and educational services for these students.

I would also like to share some details with you, explaining how the detectors work. When an alert is triggered, a message gets sent to my administrative team and I. Cameras in the halls immediately turn their attention to the doors of each bathroom. We monitor this from our computers and our phones (from the halls). If it is Vape then the alert will indicate that it is Vape, measuring the particles that are in the air. These detectors will pick up on other activities as well. For example, if someone throws water on the sensors or tries to rip the sensors off the wall, the alert will come to us labeled as "Tampering." If there is screaming and yelling in the bathrooms, the detector will tell us that there is potentially an unsafe situation in the bathroom. This technology is very intuitive and very accurate. Our hope is to utilize these devices in a way that will aid us in providing the safest possible environment for our students. We are also utilizing this resource as a means to help educate students on the dangers and health risks of vaping.


